Location

The property occupies a prime position in the heart of Sheffield city centre, fronting directly on to Tenter Street at the junction with Scotland Street close to West Bar roundabout. The property is located opposite the Pennine Centre – HSBC offices and is on the fringe of the Cathedral Quarter Central Business District. Over recent years, this area has seen significant inward development, including speculative office and residential schemes, including Velocity and Metis. The building is well located for the facilities of the city centre and is within a short walk of the main University Campus.

Description

The building comprises three main elements comprising a six storey main tower/office facility, five storey extension providing additional offices and storage and a substantial garage/warehouse facility with accommodation over three floors. The complex sits on a substantial site, which we are informed extends to approximately 0.9 acre.

This complex is ripe for redevelopment/refurbishment with potential end target markets including office, residential, hotel and leisure, subject to planning.
